Family Name: Scott

Background to the name

One of the most powerful of the Border families, the name is reputed to derive from the Scots who migrated to Dalriada (Argyll) from Ireland and the surname is found in all parts of Scotland. The origins of the name must nevertheless remain obscure and the subject of fable and speculation. We are on firmer historical ground with the first record of the name Scott in 1120 when Uchtred filius Scot witnessed the foundation charter of Selkirk in 1120. The Christian name 'Uchtred' is in fact a Germanic name, most probably in circulation in the Scottish Borders because of the widespread influence of the Anglian Kingdom of Northumbria. A charter by David Early of Strathearn was witnessed by Henricus le Scotte around 1195. A famous member of the Scott family was the purported wizard Michael Scott; he was from the Tweed Valley, but lived in Fife where he gained his reputation for magical skills.

In the Ragman Roll (all nobles and landed gentry were required to sign by Edward I in 1296) there are six Scott lairds. One of these, Sir Richard le Scot of Murthoxton (now Murdostoun) in Lanarkshire may have acquired those lands by marriage—he also had estates in Selkirkshire. It is his line which became established and spread out between Ettrickdale and Liddesdale. Sir Michael Scott, 2nd Laird of Buccleuch was a staunch supporter of Robert the Bruce and distinguished himself at the Battle of Halidon Hill in 1333. The Lanarkshire estate was exchanged for Branxholm in Selkirkshire as the family became more and more established in the Borders.

In the 15th century, as was common in the Borders, the Scotts quarrelled frequently with their neighbours, particularly the Kerrs. The feud caused the deaths of both chiefs and was only resolved by marriage during the chieftainship of the 10th Laird. The 13th Baron was created Lord Scott of Buccleuch by James VI and in 1619 Lord Scott was created an Earl. The male line failed and Anne, Countess of Buccleuch married the illegitimate son of King Charles II, the Duke of Monmouth. Charles created the couple Duke and Duchess of Buccleuch but the Duke supported the protestant cause and at one stage led an unsuccessful rebellion against King Charles. The third Duke of Buccleuch married the heiress of the Duke of Queensberry (the Douglas family) and became one of the richest men in Britain. In the 19th century, Sir Walter Scott (from a junior branch, the Scotts of Harden) changed Scotland's image forever. The Duke of Buccleuch today is one of the largest landowners in Scotland and the art collections at the family's great houses of Drumlanrig, Bowhill and Boughton are internationally famous.

Original Historical Records held at the Heritage Hub

Dates and names provide you with the backbone of your research, but finding out details about your ancestors (e.g. their family, where they lived, working life, social life and the environment they lived in) can be even more rewarding. At the Heritage Hub we hold a vast amount of original historical records including some on Scotts. We have listed some examples below. Remember most Scotts will not have the same family connections to the ones written about in books and studies already done – the challenge is to find your own Scott story!

Scott's hidden in records

Some of the most important references to your Scott family may be found in series of records for the council, parish, local society, legal records, records of law and order, poor relief or the records of a business or place of work. For example Scotts will be listed in records of those receiving poor relief, criminal and police officer registers, wages and salary books, minutes of town and local councils – if they were a councillor. Newspapers are another good source for events and

listing of people involved in local organisations such as churches, clubs and societies. We also have some records for these. Newspapers can also list obituaries. A good source for the 1820s are the Wood Maps for Border towns. These maps have who owns each plot of land in each town. Further land owning records to look at are Sasines, title deeds and land transactions, and valuation rolls.

Example of a Scott story

Janet Scott, Jedburgh Union Poorhouse Register, 1871

Janet Scott is one of the many names preserved in the poor law records.

She first appears in the Jedburgh Union Poorhouse Committee as an applicant for parish relief in 1871. A single parent, poor, and moving from farm job to farm job, she was obliged to seek support from the parish when a horrific accident left her disabled.

However her story also demonstrates her resilience: she was able to endure the inevitable conditions and stigma of being a "pauper" and make an independent life for herself and her family afterwards.

Although the union poorhouses were built with the intention of relocating the unemployed to towns to find jobs, many of the unfortunate people who were forced to apply to them for relief were physically disabled or elderly, with little or no hope of being able to work. Often deserted wives or single women with children turned to the parish for support - usually as a last resort.

The admission record of Janet Scott gives us a glimpse of the desperate situations in which applicants to the poorhouse found themselves. A single mother of two children and a baby, she applied to the Jedburgh poorhouse as a result of being 'wholly disabled' by a cart falling on her. The record shows she was on parish relief for at least three years.

However, the census records show that she managed to move on from parish support and even have another child. By 1881 she was living in a cottage in Eckford, and she and her two eldest daughters were earning their living as agricultural labourers.
